1. What experience do you possess that demonstrates analytical skills relevant to the redistricting process and voting rights, and demonstrates your ability to comprehend and apply the applicable state and federal legal requirements?

As a consultant in the field of investor relations for biotechnology companies, I have demonstrated an ability to perform necessary analytical tasks and to understand and apply complex state and federal legal requirements to corporate actions. I am required to analyze vast amounts of financial and investment data to target investors, target new investors and review corporate performance. I am well versed in Excel and I possess a keen ability track and organize complete data sets. Also related to my career in investor relations. I am responsible for communicating complex scientific data. Although I am not a scientist, I have a talent for reviewing complex scientific studies, gaining an understanding of the key components and finally communicating these complex ideas and concepts into more simple terms that the average investor could understand, all the while, maintaining the true meaning of the scientific discoveries and disclosing information in compliance with federal, state and local regulations. I believe also that my experience reviewing and implementing complex SEC and FDA regulatory requirements has prepared me for the complexities of the redistricting and voting rights. Whether in my professional life, my volunteer efforts or raising my children, I have always been a rule follower and I believe that we must operate within the boundaries of the law. We have rules and obligations as Americans, and we are bound to follow the tenants of the Constitution and the Bill of Rights. The right to vote is the cornerstone of our American experience and fair and honest redistricting is key to ensuring our American values persist.

2. What experience do you possess that demonstrates an ability to be impartial?

I have a reputation of honesty, integrity and professionalism. As a volunteer for San Diego Schools, an organization working to improve education for all in San Diego County, I work closely with San Dieguito Board of Trustee member Maureen "Mo" Muir who often says that I have a unique ability to see both sides of issues. And sometimes when disagreements or differences of opinion occur, I always keep my cool, remain calm and professional. And I know first-hand how difficult it is to say no to power. On many occasions, I had to direct my management team to make changes in order to comply with either legal or regulatory requirements. As Board President of the Canyon Crest Academy Foundation, I managed our staff and our Board with straight-forward honesty and fairness, guided our Bylaws, which are the regulations for a nonprofit operation. My father was born in London. And he was raised in a society that did not allow equal opportunity for all. He immigrated to the United States and was adamant that his children were raised to believe that everyone was equal and deserved equal opportunity.

3. What experience do you possess that demonstrates an appreciation for the diverse demographics and geography of the County of San Diego?

I feel like I know San Diego. I have lived in San Diego County since the early 1990s and my husband is a proud second-generation San Diegan from EI Cajon. As avid hikers and campers, we have seen the stunning beauty and quiet strength of the backcountry to the cool breezes of the Pacific. As a volunteer, I have traveled the county and through those efforts, I have gotten to know each of the communities and their unique characteristics. As a political volunteer, I have traveled Oceanside to share my passion with residents and to convince them that a white woman from Del Mar can understand the complexities of their lives and encourage them to vote. And if you have ever done canvassing, you will not that it is not easy. You never know who is going to answer the door and if they will agree with you. And if they didn 't agree, I was always affable and respectful of their opinion. As a co-founder of San Diego Schools, I am responsible for connecting to school districts from Fallbrook to Mountain Empire and from San Ysidro to Borrego Springs. And in the process, I have developed relationships with school district personnel, school board members and parents. I have learned that the Superintendent of Borrego Springs is personally connected to his community, often boasting of his students 4-H achievements. Larger school districts like San Diego and smaller districts like Julian share a common goal of providing quality education and differ based on their community, geography and culture. I have come to see that these districts represent the communities in which they operate. I have enjoyed learning about each one. I believe that my professional and volunteer experiences and my personal beliefs will enable me to work as team player and to perform the duties as a

member of the redistricting committee.


