



## D. Experience Qualifications

State law requires candidates demonstrate experience in areas related to redistricting. Please provide responses to the following questions.

1. What experience do you possess that demonstrates analytical skills relevant to the redistricting process and voting rights, and demonstrates your ability to comprehend and apply the applicable state and federal legal requirements?

My education, training, professional and personal experience demonstrate acquisition of and application of the necessary analytical skills to participate effectively in the County redistricting process and that I will be able to comprehend and apply the requisite state and federal legal directives. I am a licensed attorney in the State of California. I attended primary, secondary and post secondary schools and universities in California. I completed the SDSU teacher preparation program and obtained a lifetime (lapsed) teaching credential. I have extensive research skills acquired in pursuit of my lifelong education and employment endeavors. I worked in my law school library. I am experienced using online legal search engines and other research engines such as Lexis and Google Scholar. I am also familiar with periodical and journal indexes and legislative intent tools. I can read and interpret maps, graphs, and charts and can absorb and apply statistical information. I appreciate that information may be qualitative or quantitative and am mindful that some intangible considerations are difficult to quantify. I am self reflective and receptive to constructive criticism. These traits enable me accept review of and adapt analytical conclusions.

Evaluating information experience comes from years careful and deliberate presentation of information gathered to substantiate and achieve express goals and results in legal forums. I am naturally logical and rigorous in methodology. Resolving ambiguities, distinguishing fact from opinion and establishing veracity and credibility are the hallmarks of my professional life as an advocate. For example, I worked on a health initiative studying health and access to care and wrote a document explaining the funding streams available to obtain healthcare for foster children. Information had to be gathered, collated and expressed to the satisfaction of the grantor and the local juvenile dependency system leaders. Others examples include writing and supporting grant proposals, educating juries and tribunals and drafting legal and educational documents. The ability to apply legal concepts in conformance with the law is also demonstrated by my trial practice in multiple tribunals. This skill was also utilized and developed as a law office manager complying with employment and ethical requirements imposed by law.

I am a team player who embraces group collaboration to ensure knowing decision making and the integrity of the resulting conclusions. As a lawyer, manager, employee and co-worker the ability to work in groups is reflected in the many collaborations with the court, bar, other nonprofits and government agencies I have worked with over the years. Additionally, in teacher preparation school much emphasis was placed on learning to work effectively in groups as a teacher and in teaching children how to work with others. I have learned that effective work groups are tailored in size and composition to the task(s) at hand. Team players are good listeners, respectful contributors and perhaps most importantly, patient with and trusting of the process by which the task(s) will be accomplished. I expect that information for redistricting purposes comes from a variety of sources whose reliability and credibility must be assessed. The wider the lens examining this material, the more likely that its content is thoroughly vetted and conclusions resting on its base are trustworthy and reliable.

#### 2. What experience do you possess that demonstrates an ability to be impartial?

Impartiality requires one to put aside their personal beliefs and preconceptions, to take into account divergent viewpoints and arguments in order to fairly assess a situation in a neutral state of mind to achieve a just result. As an licensed attorney, I receive regular training in elimination of bias. As a trial attorney, with 40+ jury trials conducted, ascertaining prospective jurors' ability to be fair and impartial was essential. The legal instructions on this idea drove home the nature of impartiality. I would have to put aside my own biases to accurately select jurors who would be fair to my client. Similarly, I have served on several juries where my ability to be impartial was precisely examined before I was selected. I found I was able to listen and judge the facts impartially. In those cases, I was required to put aside any personal bias to assess the credibility of the individuals establishing the facts and determine the outcome for the accused.

In teacher preparation school, much emphasis was placed on techniques to discover and eradicate hidden biases to avoid making unfair and uninformed assumptions about students. My experience as a supervising attorney required impartiality when resolving employee and client disagreements and disputes. Other situations where I was required to be impartial included multiple stints as a moot court competition judge, participation in mediation projects like the San Diego Mediation and Restitution Service (dealing with school age children) and Teen Court. My ability to be impartial will enable me to gather, evaluate and weigh the sources of and information acquired to diligently map redistricting lines in an non-partisan manner that effectuates the goal of making every vote count and every voice heard. My commitment to impartially carrying out redistricting duties will enable me to effectively defend my decisions and reasoning and assure compliance with Constitutional, state and federal law.

3. What experience do you possess that demonstrates an appreciation for the diverse demographics and geography of the County of San Diego?

I was a military brat and spent most of my first 4 formative years in Panama. Onward, from kindergarten through 5th grade, I lived and attended school in New York, California (2nd grade), Hawaii and Delaware. I thrived in this varied upbringing. This exposure is at the core of my world view and appreciation of diversity. Since mid-1965, I have resided in Southern California about 15 miles from the Mexican border, excepting a stint at college in Chico, CA, studying agriculture. I studied Spanish in 2nd grade, as was common in California schools back in those days; Spanish was my chosen language focus in high school and college. I am interested in history and have studied San Diego County natural and historic roots, from the first peoples, to the Spanish and immigrants from the east.

Academically, I have formally studied the natural history of San Diego County and its unique geology via the UCSD extension program. My studies in agriculture and residence in Chico, sensitized me with the concerns of farmers about water rights, environmental management, public lands utilization and urbanization, to name a few. My legal service work has also attuned me to a sense of marginalization and under representation felt by residents of small, rural and remote counties.

I was a public interest lawyer in San Diego for virtually all of my legal career and happily served a diverse and impoverished client community in virtually every courthouse, and other administrative forums, in the County. These travels have shown that specialized communities gather in distinct locations, microclimates and terrain to achieve a wide variety of industrial, technological, and agricultural goals. These combinations form patterns of San Diego County society and nurture its art, literacy and values.

My interest and appreciation for the diversity of the County, in all its guises, has been honed by travel experience, including countless road and camping trips all over the County, State and country. I have visited Baja and southeastern Mexico many times, traveled to Tahiti, Costa Rica, and Jamaica on short trips and spent 3 weeks in China in 2015 and most recently, 3 weeks in India in 2018.

Lastly, my longstanding residence in the county, just 3 miles from my old high school, underlines my love of this county, its many faces and perspectives and its sheer physical beauty. I would be honored to represent the various interests of the citizens of this county fairly and impartially to ensure every vote counts.


