The selected eight Commissioners will meet to choose the remaining six Commissioners from the remaining pool of qualified applicants.

D. Experience Qualifications

State law requires candidates demonstrate experience in areas related to redistricting. Please provide responses to the following questions.

1. What experience do you possess that demonstrates analytical skills relevant to the redistricting process and voting rights, and demonstrates your ability to comprehend and apply the applicable state and federal legal requirements?

I have both an educational background and work and volunteer experience that has provided me with deep and varied opportunities to practice and hone my analytical skills, beginning with an undergraduate degree in Biology (B.S.). This undergraduate training gave me a foundation in critical thinking, where I learned the scientific method, which means one employs a process of developing and evaluating hypotheses through analyzing data and evidence. Working for a cancer research organization as a research study coordinator, I was exposed to the science of clinicial trials and the statistical analysis of data that these trials produce. Much later I returned to graduate school and earned a Master's degree in Literature and Writing, where my focus was on critical analysis and literary theory. I then taught critical analysis and analytical writing to undergraduate students. As a teacher of literature and writing, I continued to draw on the long-ago learned lessons of the scientific method to teach my students how to analyze a piece of writing: by examining the text, or data, to guide you toward a thesis, or understanding, about that piece of writing.

In addition, in nearly 30 years living primarily in San Diego County, I have served in various volunteer roles where I have continued to use my critical analytical skills, including:

Cardiff School Board Trustee where I also served a one-year term as President, with oversight and governance of a K-12 school district, including reviewing and adopting budgets and assuring that the district complied with local, state and federal regulations;

San Diego Women's Foundation, member of several committees including the grants committee, which performs an annual study of developing issues and needs in San Diego County to determine where the SDWF might consider directing grant funding;

Planned Parenthood of the Pacific Southwest Board Director, with oversight and governance responsibility, along with strategic leadership, of a 3-county health care provider, member of several committees, including the Budget & Finance Committee, reviewing annual budgets and other financial and technical information to guide decisionmaking;

San Diego Foundation Community Scholarship Program, which awards hundreds of scholarships on behalf of SDF donor-advised scholarship funds, where I read, evaluate and interview applicants, and determine awards in collaboration with others, every Spring;

Planned Parenthood Affiliates of California Board Director, a statewide advocacy group consisting of members from each of the PP affiliates in California, providing governance and oversight as well as strategic leadership;

Various other volunteer activities including at my children's schools throughout their k-12 years.

I have no doubt that my background and experience demonstrate that I am capable of comprehending and interpreting dense and technical information; discerning fact from opinion; weighing and evaluating data and information from myriad sources and determining what is pertinent from what is irrelevant; applying legal standards and other guiding principles to make decisions; and synthesizing all these considerations while working in collaboration with others to reach consensus.

2. What experience do you possess that demonstrates an ability to be impartial?

The regulations governing redistricting commissions describe impartiality as having "the capacity and willingness, while serving as a member of the commission, to set aside his or her personal views . . . in order to evaluate information with an open mind and make decisions that are fair to everyone affected. . . that are in compliance with the United States Constitution, the Voting Rights Act of 1965 . . . and the criteria set forth in subdivision (d) of section 2 of Article XXI of the California Constitution."

I believe deeply in our democratic system of government and in protecting the power of the people to elect a representative government. This new redistricting process for creating districts is one I completely support, especially because it is intended to remove the inherent bias and politicization that previous districting methods allowed and to provide for fairer, more representative outcomes in the electoral process. Its imperative for a commissioner to be fully committed to producing a fairly drawn map that accurately reflects the electorate, a commitment I will hold myself to unequivocally.

In all of my professional and volunteer experiences, from coordinating cancer research studies to teaching literature and writing, to evaluating scholarship applicants or non-profits for grant awards, it has been important that I reach sound, defensible decisions, which necessarily requires using logic and reason, and relying on facts and evidence to inform and support the decisions. In many cases, I have also been responsible for developing the objective criteria on which to assess a project, a student, an organization, or a budget proposal, and then employ that rubric in the evaluation process.

It takes a kind of discipline, one that I believe I possess, to set aside one's predilections, and instead focus on the broad objective of the task at hand. In many cases, I have done this kind of work in a group, whether as a member of a board of directors, a member of a steering committee, or an appointed advisory group. In this setting, I have seen how critical it is to remain impartial and open, not only to all the information presented, but also to the various perspectives, ensuring that all voices are listened to, as this is necessary for a productive process that will result in achieving sound consensus decisions.

3. What experience do you possess that demonstrates an appreciation for the diverse demographics and geography of the County of San Diego?

I am the Mexican-American daughter of parents who were from the border region of South Texas. I moved to San Diego County with my husband and two young children in 1991, never expecting that nearly 30 years later I would still be here, happily calling San Diego home.

With the exception of two years in the Bay area where we relocated temporarily for my husband's job, I have lived in coastal North County San Diego, in Carlsbad, Cardiff, Del Mar and now unincorporated Rancho Santa Fe. Despite the fact that I've lived within a small radius of San Diego County, I know the county beyond my neighborhood, and appreciate the stark contrasts between the coastal, mountain, desert, agricultural, urban, and suburban areas. I've camped in Heise County Park, hiked many trails in Laguna Mountain, taken classes at CSUSM, walked precincts in Vista and Oceanside, volunteered at Juvenile Court and Community Schools with a non-profit (one in Vista and one in downtown San Diego), attended events at the Jacobs Center, toured health centers (City Heights, Chula Vista, Kearny Mesa, to name a few) and read scholarship applications of students from every cultural background, most of them the first in their family to attend college.

I have become knowledgeable about the many diverse cultural and ethnic communities that call San Diego home. As a member of a philanthropic foundation, I have read grant applications from nonprofits serving these communities around the county on issues as varied as workforce preparation, mental health support, immigration and refugee needs, and human and sex trafficking. As a director of a nonprofit whose mission is to provide health care to marginalized communities throughout the county, I've learned about and seen where some of our most vulnerable population live and seek essential care. A driving focus in that organization has been to improve diversity of leadership, and to that end, I have completed some diversity, equity and inclusion training, both general and specific to SD County. In short, I am well informed about not only the how DE&I operates, but I understand the specific geographic and demographic diversity of our county as well as the economic class diversity that is present in San Diego County.

As a Latinx woman, I'm all too aware of the ways in which marginalized voices are either silenced or ignored. I cannot claim to know exactly what other marginalized groups have experienced, but I believe I have a keen understanding of how it feels to be part of a group whose perspectives and lived experiences have not been considered--deliberately or not, due to bias or not--when laws and policies are enacted that affect us nonetheless. I am committed to ensuring that diverse perspectives are listened to and incorporated in the decisionmaking, as well as to questioning the assumptions that frequently erase minority voices so that a fair and inclusive outcome is achieved in the redistricting process.
