## **Application Timeline**


July 31, 2020	Applications must be received by the San Diego County Clerk of the Board of Supervisors no later than 5 p.m.
August 26, 2020	From the pool of qualified applicants, the Clerk of the Board of Supervisors will post the names of the 60 most qualified applicants. The names will be posted online for at least 30 days.
October 13, 2020	The Clerk of the Board of Supervisors will conduct a random drawing of the qualified applicants at the Board of Supervisors meeting to select eight Commissioners.
October 22 and November 5, 2020	The selected eight Commissioners will meet to choose the remaining six Commissioners from the remaining pool of qualified applicants.



## D. Experience Qualifications

State law requires candidates demonstrate experience in areas related to redistricting. Please provide responses to the following questions.

1. What experience do you possess that demonstrates analytical skills relevant to the redistricting process and voting rights, and demonstrates your ability to comprehend and apply the applicable state and federal legal requirements?

I have skills, qualifications and life experiences that will directly assist the CSDIRC in successfully completing its assigned tasks. These include analytical and statistical skills, area expertise, administrative experience, an ability to clearly comprehend and articulate complex concepts and demonstrated skills at consensus building that come from three decades of working with people from diverse communities to achieve common goals.

I have a Ph.D. in Political Science (American University, 1988) with comprehensive areas of Political Theory, Comparative Politics and Quantitative Methodologies. I have 30 years teaching empirical research design to undergraduate and graduate students. My teaching, researching and writing about American, Californian and San Diego politics and government also provides me a strong understanding of the literature and practices (both best and worst) of redistricting in historical and contemporary context. I am fully cognizant of the prevailing and controlling constitutional provisions, statutory laws and judicial precedents as applied to voting and redistricting, having taught and written about them for many years. I understand the genesis and evolution of the Voting Rights Act and the impact of subsequent legislative revisions and judicial decisions such as Baker v. Carr and Shaw v. Hunt upon its implementation. I am well versed in contemporary legislation and current case law emerging from state and federal courts on gerrymandering and redistricting.

I have significant experience in educational and institutional leadership effectively working with diverse constituencies to resolve major issues, always under significant budgetary and time restraints. I have ample experience in translating government statute and code into practical policy. I understand the importance of team building and establishing effective processes to set priorities for an organization and have practical, successful experience in program administration, staff recruitment and motivation, resources allocation and the develop of time tables necessary to achieving organizational goals. I am a recognized expert in communicating complex ideas in accessible ways to audiences of every level of educational and demographic backgrounds (for which I was recognized as one of the top 5 community college professors in America by the Association of Community College Trustees). My recognized regional and national reputation as a non-partisan political analyst speaking to diverse audiences across partisan lines will allow me to pursue and communicate the mission of the CSDIRC.

#### 2. What experience do you possess that demonstrates an ability to be impartial?

I earn my daily bread predominantly teaching courses in political science to undergraduate college students. Some in my field see their role as that of proselytizer and prophet. I never had. I believe it is my job to, as effectively as I can, present the various facts, theories and contending viewpoints that make up my discipline to students from a diverse range of backgrounds and traditions, all of whom are only beginning to assemble themselves as political beings. One of the highest compliments I am routinely paid by my students and my colleagues is that, after all these years, they are not sure just where my partisan loyalties lie. (For the record, they lie with the common good.)

A professional preference for impartiality has guided me in my role as a regionally and nationally recognized non-partisan political analyst. I've given almost two thousand interviews on politics to local, national and international media, speaking to audience across the political divide by focusing on truth and facts, not emotion and partisan loyalty. I've been a commentator for our local public radio and television station KPBS (with a strongly liberal leaning audience) for over 20 years and am the political analyst for our local Fox affiliate (with a very conservative audience) for the past 6 years. If I can appeal to both these audiences saying the same things I know I'm speaking more to truth than partisanship. I have been asked by a wide diversity of social and political groups in San Diego to moderate political panels and debates based on my reputation as an articulate and impartial speaker.

It was my privilege and honor to cofound and work with the Rev. George Walker Smith for almost a decade on the community initiative Restoring Respect which has endeavored, through annual conferences and community engagement events, to bridge divides and bring communities together for common purpose. As director of the University of San Diego's/San Diego Community College District's Institute for Civil Civic Engagement I have had the honor of working with community leaders from around San Diego to develop our region's social infrastructure to engage in balanced, fact-based civil dialogue and working to bridge partisan divides.

I was trained in empirical quantitative political science and, while values are ultimately inseparable for the making of informed, qualitative decisions, I know how to look at a data set and see it for what the data says and not for what a preformed opinion says it should say. In the classroom that means I impartially evaluate the performance of students from across the demographic spectrum. In public life it means I can take positions based on as objective a measure of the public good as I can assess in the given situation. I will work passionately and impartially for the collective good as a member of the CSDIRC.

3. What experience do you possess that demonstrates an appreciation for the diverse demographics and geography of the County of San Diego?

I have a great appreciation for—and a love of—the unique geographical and social entity that is San Diego County. I've lived in San Diego County (with the exception of 4 years spent in Washington, D.C. getting my doctorate in Political Science and 1 year teaching in Russia as a Fulbright Senior Scholar) for most of the past 47 years. I went to school here, work here, met my wife and raised 4 daughters in here. It has been my good fortune in life to call San Diego, one of the most dynamic diverse regions of the country and the world, my home. My professional life has been spent trying to make San Diego a better home for all its residents.

My professional life has given me opportunities to meet and work with people from all communities that constitute San Diego county. I've taught and worked with students of every background from every part of the region. As director of our Institute for Civil Civic Engagement I've worked with organizations and communities across the region. I've had the opportunity to dialogue with people across the county in forums and events and through my political commentaries and interviews that have appeared in all of the County's media outlets. I've successfully worked with San Diego economic, political, non-profit and thought leaders across the political and demographic spectrum. Through this all I've pursued one overarching goal - to work to bring together people in a region rich in diversity yet rife with potential division to achieve the higher public good. I am keenly aware of the major fault lines in San Diego County's social and political map. The self-sorting of our population into like-minded communities producing geographic and socio-economic divisions continues to divide us. San Diego south of I-8 is different than San Diego north of Miramar Road. San Diego east of Grossmont is different than San Diego west of I-5. At the same time San Diego County provides successful examples of people transcending their geographical, political, cultural, ethnic and social divisions to form a greater community in a nation built upon such transcendence.

I understand that for a representational democracy to function representatives must actually be representative of the peoples they represent. The purpose of the CSDIRC is to create an electoral framework that can allow the election of a county government that represents our residents across partisan, cultural, ethnic, economic, gender and sexual orientation diversity. The CSDIRC must work to advance an electoral systems that encourage all San Diegans to participate, cooperate and build consensus that benefits all members of our County community. My experience would help the CSDIRC to achieve this mandate.


