1. What experience do you possess that demonstrates analytical skills relevant to the redistricting process and voting rights, and demonstrates your ability to comprehend and apply the applicable state and federal legal requirements?

My entire life since graduating from the United States Naval Academy has allowed me to develop analytical skills as well as the ability to comprehend and apply applicable federal and state laws.

At Annapolis I received a BS degree with a major in Political Science. The core course load was very technical and analytical in nature.

After graduating I was commissioned in the U.S. Marine Corps where I served a 26 year career as a fighter pilot. This required analytical skills involving sophisitcated jet aircaft systems; understanding and exploiting manuvering characteristics of enemy fighter jets; as well as being able to read and interpret maps.

I obtained a law degree going to night school, while flying during the day. After retiring, I began a second career where I served as an Orange County Deputy District Attorney for just short of 20 years. I spent the majority of my career prosectuing violent gang felonies and homicides of all nature. This required the comprehension, understanding, interpretation, and ability to explain legal statutes and complex principles.

After my second retirement, I have become involved with Rotary, continuing on my lifetime of service above self.

For over 50 years I have exercised, developed and refined a foundation of abilities that makes me confident that I have the requisite skill set to be a most effective member of the County of San Diego Independent Redistricting Commission.
