July 31, 2020 Applications must be received by the San Diego County Clerk of the Board of Supervisors no later than 5 p.m. August 26, 2020 From the pool of qualified applicants, the Clerk of the Board of Supervisors will post the names of the 60 most qualified applicants. The names will be posted online for at least 30 days. October 13, 2020 The Clerk of the Board of Supervisors will conduct a random drawing of the qualified applicants at the Board of Supervisors meeting to select eight Commissioners. October 22 and The selected eight Commissioners will meet to choose the remaining six November 5, 2020

Commissioners from the remaining pool of qualified applicants.



### D. Experience Qualifications

State law requires candidates demonstrate experience in areas related to redistricting. Please provide responses to the following questions.

1. What experience do you possess that demonstrates analytical skills relevant to the redistricting process and voting rights, and demonstrates your ability to comprehend and apply the applicable state and federal legal requirements?

I graduated from Tulane University in New Orleans, Louisiana with a B.A. with Departmental Honors in American History in 1971; a M.A. in American History in 1973; and a J.D. in 1974. Upon admission to the Bar, I served as a Captain in the U.S. Army Judge Advocate's Corps at Fort Ord, California from 1974 to 1978. I thereafter practiced law in Louisiana and Texas until I was appointed a Federal Administrative Law Judge in 1997 for the Social Security Administration. After supervising the Houston (Bellaire), Texas Social Security Hearings Office as Chief Judge, I applied to transfer to the U.S. Department of Labor where I served as an Administrative Law Judge in the San Francisco, California office from 2002-2013. After moving to Fallbrook, California in 2012, I retired from federal service in 2013 and have since been self-employed as Advanced Mediation Service engaged in mediation and arbitration services nationwide.

I have been engaged in analytical analysis first as a student and then as a lawyer, judge, mediator and arbitrator all of my adult life. I tried over 100 courts-martial during my four year stint in the U.S. Army and then tried cases in state and federal courts in over a dozen different states while practicing civil trial law. As a Social Security and later, U.S. Labor Department, Judge, I presided over thousands of cases and wrote and issued decisions based on analysis of facts and law.

I believe my professional experience as outlined briefly above together with my longstanding interest in American History amply qualifies me for appointment to the Independent Redistricting Commission.

I served as a Federal Administrative Law Judge for 16 years. My sole duty was to render impartial decisions on a myriad of issues involving individuals, corporations and federal agencies. Following my retirement from federal service, I have continued to exercise impartiality as a mediator and arbitrator in hundreds of cases involving individuals and corporate and governmental entities. My training and experience in these legal positions amply demonstrate an ability to be impartial.



3. What experience do you possess that demonstrates an appreciation for the diverse demographics and geography of the County of San Diego?

Since moving to Fallbrook in 2012, I have traveled throughout all of San Diego County as I have a love of travel and exploration. My wife grew up in the Mt. Helix area of La Mesa. She attended elementary and junior high in El Cajon followed by Monte Vista HS, Grossmont College and UCSD. She has two brothers living in Santee and Fallbrook and a sister with a condo in downtown San Diego. Her parents continued to reside in the Mt. Helix area home where she grew up and we visited them frequently. We moved to Fallbrook in order to take care of them when my wife's mother broke her hip at the age of 94. We moved them into a retirement community named Silvergate in Fallbrook. Her Mother is now 102. Even before my retirement as a Judge I often heard U.S. Department of Labor cases in San Diego involving San Diego County residents and corporations. I took advantage of my downtime between trials to explore the wonders and people of this county. My wife is an avid birdwatcher and naturalist and she introduced me to the divergent beauty of the desert in Anza Borrego, the mountains of Palomar and the Lagunas, the beaches of the coast from Oceanside to the Silver Strand of Coronado and of course the gardens, nurseries and groves of Fallbrook, Vista, De Luz and the coastal cities. As an avid gardener, I belong to several plant societies which meet in various areas of San Diego County. I have been a member of The Rotary Club of Fallbrook since 2012, and have served as the club Chairman of The Rotary Foundation Committee since 2014.
