August 26, 2020	From the pool of qualified applicants, the Clerk of the Board of Supervisors will post the names of the 60 most qualified applicants. The names will be posted online for at least 30 days.
October 13, 2020	The Clerk of the Board of Supervisors will conduct a random drawing of the qualified applicants at the Board of Supervisors meeting to select eight Commissioners.
October 22 and November 5, 2020	The selected eight Commissioners will meet to choose the remaining six Commissioners from the remaining pool of qualified applicants.



Response to Section D. Experience and Qualifications

1. What experience do you possess that demonstrates analytical skills relevant to the redistricting process and voting rights, and demonstrates your ability to comprehend and apply the applicable state and federal legal requirements?

I retired from the cable television industry as vice president and general manager. In that capacity, I was responsible for all the financial, budgetary, human resources, promotional and compliances with federal, state and local regulations for my systems.

My successful advancement in this industry required the analytical skills to combine regulatory oversight with customer care and our company's needs. Over the thirty years in the cable and telecommunications industries, I have read, understood and complied with rules and laws from many regulatory agencies.

During my tenure as VP/GM in San Diego County, the cable industry was federally reregulated and I was required to know and understand the new law and how it would affect state laws and local franchise requirements. While complying with federal law, I had to ensure we maintained the law and spirit of the needs of our customers and local regulators. We were successful.

I have read the state rules on redistricting to the extent that I understand that it was established to be a non-partisan process decided upon by citizens following state guidelines. Additionally, I understand the purpose was to create fair and equitable voting districts for all Californians. I agree wholeheartedly.

2. What experience do you possess that demonstrates an ability to be impartial?

As the general manager for up to 400 employees, our company's success rested upon the work of our associates. In order to obtain that needed effort, they had to trust our company and my judgment. To earn that trust, I had to be fair and understand their concerns and balance them with customer care and company objectives.

We had an open door policy at my offices where I ultimately arbitrated disputes and counseled concerns. Our success as a company depended on the team trust. We had many successes. (These can be provided upon request.) My willingness to listen and learn, was a great benefit to me, our staffs and our goals. Teamwork is impartial.

In Riverside, I served on the mayor's Education Advisory Committee. We were diverse in politics, experiences and religions but united in the goal of attracting students to local colleges and post secondary education venues. The good of the students and the community were our main objective.

It is difficult, at times, to avoid predispositions. However, placing beneficial goals ahead of feelings overcomes most partialities.



3. What experience do you possess that demonstrates an appreciation for the diverse demographics and geography of the County of Diego?

Our proximity to Mexico and our International Airport and Pacific Rim businesses creates wonderful opportunities for us to enjoy as well as 'appreciate" diverse demographics. My spouse and I have two foreign born daughters. We adopted them at the ages of six and eight and learned to incorporate their culture into our family. One of them has married a man from yet another foreign nation and we are again learning to mesh his culture with ours. With grandchildren, we truly are a multi-racial and multi-cultural family.

Over the years I have served on the Board of Directors of many charitable and community focused organizations. As a director on a North County YMCA board, we served a broad spectrum of young people and adults. I was also a director on the San Diego Blood Bank during the year when HIV was concern. Blood is universal.

In the US Army in Vietnam, I worked alongside fellow soldiers of different races and many ethnicities. In addition, I assisted in our efforts to work with the Vietnamese providing, medical and education assistance. In my first years after college, I taught high school and worked in a poverty program – Upward Bound.

For the last four years I have volunteered at a food bank in Vista. We provide food for the hungry of all races, ethnicities and backgrounds. Hunger and poverty affect all. (We are currently on a corona virus break, but my intentions are to again volunteer when they reopen.)
