

Springboard Scenario 1

Scenario 1 represents a map that focuses on preserving BIPOC immigrant, refugee, and border communities in the southern part of the County. This is achieved by drawing the boundary of district 1 from east to west across the entire county, with a shorter north/south extent in the west and wider north/south extent in the east. While this does preserve the border areas and includes the entirety of the City of Chula Vista, National City is divided between districts 1 and 2. In the north, the cities of Encinitas and Carlsbad are kept in the same district, but they are split from their North County neighbors, Vista, and San Marcos. The unincorporated community of Fallbrook is preserved in district 5; however, Rainbow is divided between district 3 and district 5.

Springboard Scenario 2

Scenario 2 minimizes changes from the existing supervisorial district boundaries (2011) while improving the balance between districts. The biggest change is the northern expansion of district 2 to create a single district that covers the entire eastern portion of the county and the consolidation of district 5 in the northwest. Under this scenario the City of Encinitas is placed within district 5, creating continuity amongst the northern coastal cities. Indian Reservations are preserved within a single district. Except for the City of San Diego and the unincorporated communities of Valley Center and Spring Valley, this scenario does not split cities or unincorporated communities. The border areas are split between district 1 and district 2.

Springboard Scenario 3

Scenario 3 relies on major arterials as district boundaries, resulting in the division of a number of unincorporated communities, including Rainbow, Ramona, Lakeside, Valle de Oro, and Spring Valley. However, many BIPOC immigrant, refugee, and boarder communities in the southern part of the county are preserved, as are the coastal cities in the northern and central parts of the county. With the exception of the City of San Diego, all cities are maintained within a single district. Many of the neighborhoods in the City of San Diego remain intact with the notable exceptions of Del Mar Mesa and University.

Springboard Scenario 4

Scenario 4 extends district 1 to cover the entire border region, from South San Diego westward across the length of the county. Similarly, district 5 runs west to east and includes the northern cities of Carlsbad, Oceanside, Vista, and San Marcos. Cities along the highway 78 corridor are split between district 3 and district 5. However, all municipalities are maintained within a single district, with the exception of San Diego. Coronado is placed within district 1 while the Point Loma area of San Diego is placed within district 4 along with other coastal neighborhoods in the City of San Diego.

a. Municipal Boundaries

- This layer is used as an overlay to locate and identify municipal jurisdictions for parcels, roads, addresses, and other data layers. This dataset also identifies unincorporated areas of the county. The dataset is updated when SanGIS is notified by the San Diego Local Agency Formation Commission (LAFCO) of a recorded annexation or detachment and as a result of ongoing land-base maintenance activities.

b. Indian Reservations (Tribal Areas)

- This dataset consists of polygons representing Indian Reservations in the County of San Diego as documented by the County of San Diego Assessor's Office, Mapping Division. An Indian Reservation is an area of land managed by a native American tribe under the United States Department of the Interior's Bureau of Indian Affairs. The polygons are intended to represent those lands recognized as part of the Indian Nation by the Bureau of Indian Affairs (BIA). The data does not include parcels that may be owned by a Tribe but which are not officially recognized as reservation lands by BIA. Because tribes possess tribal sovereignty, even though it is limited, laws on tribal lands vary from the surrounding area. These laws can permit legal casinos on reservations for example. The tribal council, not the local or federal government, generally has jurisdiction over reservations. Most Indian reservations were established by the federal government. The name "reservation" comes from the conception of the Indian tribes as independent sovereigns at the time of the U.S. Constitution was ratified.

c. Community Planning Area (Community Plan)

- Geographic area adopted by the County of San Diego Board of Supervisors reflecting a commonality of interest, topography, access, and normally represented by a planning or sponsor group responsible for advising the County on the Group's perspective of planning issues within the boundary.

d. Community Planning Area (Community Plan) – San Diego

- Community plan boundaries for the City of San Diego land use policy plans specific to these geographic areas. Land use policies within jurisdictional boundaries have the ability to create a citywide land use and policy document called the General Plan. Many cities in California are small enough that their General Plans are single volumes. Larger cities, such as San Diego, often subdivide the city into a number of community plans, or "mini" land use policy plans for more specific geographic areas.

e. Community Villages

- These polygons delineate where the rural village and village boundaries are within the unincorporated areas of San Diego County. Village areas are mostly suburban/urban areas generally with densities of 2 dwelling units per acre and greater whereas rural village area are typically historic commercial cores and lesser densities outside of the County Water Authority boundary. This dataset represents the boundaries established by the community groups and County staff and is the proposed dataset for adoption with the County of San Diego's General Plan update.

f. Community Village Core

- For use with the Traffic Impact Fee Ordinance. They are loosely based on the San Diego Association of Government's (SANDAG) Smart Growth Opportunity Areas and altered based on the General Plan land uses.
