#### 5. Overview of the Redistricting Budget (Informational Item)

Barbara Jiménez, Executive Lead to the Independent Redistricting Commission from the County of San Diego, and Nicole Temple, co-Project Manager for the Independent Redistricting Commission from the County of San Diego, presented an informational overview of the budget for the Independent Redistricting Commission.

#### 6. Competitive Procurement of Redistricting Contracted Services (Informational Item)

#### **ACTION:**

ON MOTION of Commissioner Garcia, seconded by Commissioner Hansen, the Commission directed staff to return with the following information related to the competitive procurement of redistricting contracted services at the next regular meeting of the Independent Redistricting Commission (IRC):

- 1. Review, detail and augment the Request for Proposal (RFP) processes for the demographer and mapping services consultant and the public outreach and engagement services consultant, including providing the draft RFPs to the full IRC prior to issuance, based on the impact that such a review would have on the timeline.
- 2. Provide more details on the role of the IRC member who will serve as technical advisor for the Source Selection Committee (SSC) and clarify when/how or whether that person can have contact with the full IRC to receive their input (without violating the confidentiality requirements for the RFP process).
- 3. Revised timeline for the consideration and posting of the RFPs, along with potential discussion and review of the RFPs by the full IRC.
- 4. Advice and options on the number of members of the IRC who can sit on the SSC to serve as voting members and technical advisors, for each RFP, beyond the current suggested structure of five voting members (three County staff, two IRC members), as well as implications for the respective SSCs and Brown Act considerations.
- 5. Review the implications for small and minority-owned business participation in the RFP process, including more information and targeted discussion.
- 6. Advice and further review of how the RFPs can address the number and type of subcontractors for each contract and clarify who determines the number of subcontracts for each contract and who they are awarded to/how they are awarded.

- 7. Investigate adding an RFP for translation services and any other additional services for which the IRC needs to procure outside consultants or contracts.
- 8. Provide a comparison to how other redistricting commissions are handling procurement of contracted services and their timelines.

- 3. Types of trainings and team building activities available for IRC members
