# IRC Lessons Learned Framework

**Purpose:** Utilize the DOTMLPF-PF as a framework for the Independent Redistricting Commission (IRC) to collect, categorize and analyze lessons learned during the County of San Diego Redistricting process.

**Objective:** Examine the sufficiency, effectiveness, and efficiency of personnel and resources available during planning and execution.

**DOTMLPF-PF (Model):** Enables organizations to operationalize their strategy, capture lessons, conduct in-stride adjustments, and provide insightful and relevant feedback for future planning.

- Doctrine, Organization, Training & Education, Materiel, Leadership, Personnel, Facilities, Policy, and Finance.

# Suggested: Collect & Categorize Framework

**DOTMLPF-PF:** Doctrine, Organization, Training and Education, Materiel, Leadership, Personnel, Facilities, Policy and Finance.

- **Doctrine\***: Determine if guidelines, rules, regulations, and protocols were adequate, codified, and disseminated to the IRC and key stakeholders.
- **Organization**: Examine the structure, governance and relationships of the IRC, Staff and Contractors.
- **Training and Education**: Examine the adequacy of training and education (products/processes) for the IRC and Staff.
- **Materiel**: Determine if equipment and systems were sufficiently available --- quality / quantity to support the mission.
- **Leadership**: Examine the leadership established by the Commission, including officers, subcommittees, and Single Points of Contact (SPOC).
- **Personnel (Staff)**: Determine if the correct type (fit) and the adequate number (fill) of staff were assigned.
- **Facilities**: Determine the adequate facilities to support the IRC.
- **Policy\***: Determine if policy issues enabled or impeded the IRC in conducting its mission.
- **Finance**: Determine the adequacy of funding and the appropriateness of the budget development process.

\* Note: State Law requirements cannot be changed by the IRC. Recommendations for possible changes to State Law/policy can be included.

# Sample: Analysis Framework

SWOT process --- considers the information collected and categorized during the DOTMLPF-P process to identify:

- **Strengths**
- **Weaknesses**
- **Opportunities**
- **Threats**

...during planning, deliberation, decision making and execution of the process.

**Action-Oriented:** Continue, Modify, Cancel.
