However, I would suggest that you make a change so that District 1 includes the Historic Barrio neighborhoods of Sherman Heights, Logan Heights, and Barrio Logan, which can be accomplished by doing two things: 1) Removing the population from Pine Valley, Alpine, or other areas east of El Cajon along I-8 that might fit better in the East County district. 2) Allowing for the City of Coronado to be connected to Downtown San Diego by the ferry route, which is how the California Independent Citizens Redistricting Commission drew their maps in 2011.
