Updated: THANK YOU TO THE CHAIR AND COMMISSION MEMBERS FOR THE OPPORTUNITY TO VOICE MY CONCERNS ON THE PROPOSED REDISTRICTING.

My name is Kimberly Murray. I have been a resident of Fallbrook for 23 years. I am currently serving on the Board of the Fallbrook Chamber of Commerce as President-Elect. I have been an involved member of the community of Fallbrook for the past 10+ years.

With Fallbrook being an unincorporated area in North San Diego County, the needs and concerns of the community vary greatly and are not shared with the proposed redistricting communities of East County, South County, or the City of San Diego.

North San Diego County is a unique and separate "community of interest" Fallbrook, Bonsall, Valley Center, Vista, San Marcos, Oceanside, Rainbow, & DeLuz share many common North County services, such as Sheriff, Fire and CHP, Health care facilities, educational facilities, Resources such as water, Transit, Youth sports leagues, and social & cultural institutions. As North County communities, we collectively support the Marine Corps Base Camp Pendleton & United States Naval Weapons Station in Fallbrook.

Additionally, Fallbrook, Rainbow, Oceanside, San Marcos and DeLuz share concerns regarding agriculture and fire safety.

Bifurcating the unincorporated areas of Fallbrook from North County cities in which we have decades of established relationships for the safety and well-being of our community is damaging and detrimental to the surrounding communities which we have worked so hard in building partnerships, sharing resources. It is intrinsically crucial to maintain these solid relationships to continue to collaborate in building North San Diego County. If not, it could lead to increased crime, health concerns, increased poverty, increased fire safety issues and decreased resources.

In addition to my Fallbrook roots, I have 30 years' experience working at the San Onofre Nuclear Generating Station (SONGS) working for Southern California Edison as a Senior Finance Regulatory Manager (retiring when the plant closed). I was also the liaison to the Camp Pendleton Marine Corps Base. The relationship between SONGS and its immediate surrounding communities of San Clemente, Oceanside and Fallbrook is based upon an Emergency Response strategy. In the unlikely event of an emergency, SONGS emergency plan and the effectiveness

of it, is built upon decades of collaboration and planning with them. With spent nuclear fuel continuing to be maintained at SONGS (with no forecast of it leaving the site), the emergency response plan is required to be maintained and have a consistent, resounding voice of one County Supervisor representing North San Diego County.

In closing, Fallbrook and North San Diego County needs one Supervisor to fight and represent our community at the County Board, strongly voicing our needs, continuing to build and maintain the relationships with Camp Pendleton, Oceanside, Vista, Rainbow, and other surrounding communities. This will result in a strong, prepared, and effective North San Diego County where the residents will feel safe and secure knowing they have a committed Supervisor fighting for their needs.

I urge you to respect our community of interest and maintain a unified North County, represented by one County Supervisor.
