We residents very much appreciate the Council's decision to leave Borrego Springs within Supervisor Desmond's 5th District.

There are numerous reasons, which other residents will hopefully comment upon, for leaving Borrego Springs within District 5. My comments pertain to healthcare.

Access to healthcare is very limited for residents of Borrego Springs - only 1 FQHC clinic, 2 paramedics in our fire station and fly-in emergency air medical evacuation. All other healthcare entails a 45 - 120 minute drive.

Supervisor Desmond's Revitalization Initiative has helped us address our healthcare deficiencies. We cannot afford to lose that progress and momentum.

Supervisor Desmond and his staff have helped our voluntary Borrego Springs Covid19 Task Force to arrange 10 vaccination events for Covid and flu and 6 PCR testing events.

The Revitalization Initiative has been instrumental in allowing us to address our critical shortage of primary and urgent care, and we are now working to stabilize the Borrego Springs Fire Protection District's ability to recruit and retain paramedics.

Support from North County staff resulted in Borrego Springs Unified School District being one of the first two school districts to get an antigen with follow-up PCR testing program at our schools. Our schools have not had to close or even send a classroom of students home since.

Chuck Matthews, head of North County HHS, has arranged and even personally delivered important health information events and services to Borrego Springs.

Donna Clearly, Supervisor Desmond's policy aide, has helped us get grants that allowed us to purchase road signs, banners and storefront posters that have helped keep Borrego Springs safer from Covid19.

Without such active support from Supervisor Desmond and his staff, our small unincorporated town may not be as well protected and served by the County as it has been.
