Dear Commissioners:

Thank you for your service and your excellent efforts in community outreach on the county level redistricting process.

My name is Theresa Beauchamp. I am a 33 year resident of Encinitas and have served as a Physician Assistant in family medicine for over 25 years. I am a member of Encinitas 4 Equality and sit on its Housing Committee.

I support a redistricting map that includes Encinitas in the Coastal Corridor with Solana Beach, Del Mar, La Jolla south to Point Loma. Our sister cities hold the following common interests:

- 1. Environmental Encinitas, Solana Beach, Del Mar south to Point Loma residents love the beauty, exercise and recreational opportunities provided by our coastline and ocean. As stewards of the coastline our combined political voices have worked hard to successfully obtain federal and county resources to manage bluff erosion and sewage runoff. Encinitas and Solana Beach share guardianship of the San Elijo Lagoon habitat and trail that connects our cities. Encinitas, Solana Beach and Del Mar are connected by our coastal rail trail which offers a gorgeous 9.6 miles to walk and bike through these sister cities.
- 2. Public Health Encinitas and La Jolla are both home to Scripps hospitals and share a strong sense of responsibility to insure the safety of our healthcare workers by upholding county and state public health safety mandates. This sense of community responsibility has sharply increased during the pandemic with the barrage of misinformation disseminated that has caused mask wearing and vaccination hesitancy. These hesitancies place our healthcare workers and community at large at great risk.
- 3. Racial justice and socioeconomic equity Encinitas 4 Equality works in tandem with Solana Beach for Equality, North County SURJ (Stand Up for Racial Justice) and The Sister Cities Project. These North County justice allies are primarily located in Encinitas, Solana Beach and Del Mar. Additionally, Los Angelitos de Encinitas collaborates with Solana Beach organizations that include: the Boys and Girls Club, Casa de Amistad and La Colonia Community Foundation to support our Latinx residents. It is important to keep predominantely white, affluent activists with a passion for justice in the same district.

My vision for redistricting of District 3 is a map with a North South orientation rather than West to East. A North South orientation better reflects our natural community of common interest of suburban coastal residents that share a sense of responsibility towards our coastline, ocean, healthcare workers and social justice.
