Purpose & Objective

Situation Analysis: County of San Diego Independent Redistricting Commission (IRC) is responsible for redrawing of County's supervisorial district boundaries and has retained Asian Business Association San Diego (ABASD) to provide meeting logistics and conduct outreach efforts to increase public participation in the redistricting process as it relates to the two Draft Map Public Hearings that the IRC is required to conduct.

Objective: ABASD aims to provide high quality, professional meeting logistics support services and to increase and encourage broad and diverse community participation and input from the five supervisorial districts through the second phase of the redistricting process; the Draft Map Public hearing phase. By law, there are two required Draft Map Public Hearings that need to be held at least 30 days apart with seven day advance public notice. The agenda for the two required public hearings, provided by IRC staff, shall include a copy of the IRC's draft map(s), prepared by FLO Analytics. Hearings shall be scheduled at opportune times and on different days of the week to accommodate work schedules and to reach as large and diverse an audience as possible.

Proposal: The Asian Business Association San Diego (ABASD) will schedule and provide logistical support for the two Draft Map Public Hearings, raise awareness of the redistricting process and promote Draft Map Public Hearing participation in the five supervisorial districts. ABASD will work with its outreach partners throughout the County to communicate with the public to ensure maximum public engagement from October through December 15th, the day the final map and the final report is due to be filed with the Clerk of the Board of Supervisors.

Strategy

ABASD will utilize the same strategy employed during the first phase of the redistricting process; the Pre-Mapping Public Hearing phase and will provide scheduling and logistical support as well as outreach for the two Draft Map Public Hearings.

ABASD will schedule the two meetings in locations as the IRC directs and will continue to utilize high quality, professional audio/visual resources to conduct the two Draft Map Public Hearings.

ABASD will engage community-based organizations (CBOs), local planning groups, special districts and other organizations throughout the County, over 50 outreach partners who are part of a collaborative focused on Economic & Social Equity for the San Diego Region, and across all media, to ensure IRC accomplishes its Objective and public engagement is maximized.

Community-based organizations with whom ABASD currently collaborates include: Access, Adams Avenue Business Association, Barrio Logan Association, Chaldean Chamber of Commerce, Chicano Federation, Convoy District Partnership, Indo-American Arts & Culture Society, Jacobs Center for Neighborhood Innovation, Otay Mesa Chamber of Commerce, RISE San Diego, Rotary Club San Diego, San Diego Asian Pacific Islander Coalition, San Ysidro Chamber of Commerce, Sudanese Community Center, Urban Corp, Urban League of San Diego, the Hispanic Chamber of Commerce, and North County groups such as the Escondido and Carlsbad Chamber of Commerce, San Diego North Business Chamber, Carlsbad Life in Action, Carlsbad Equality Coalition and those groups representing rural areas such as San Diego County Farm Bureau, planning committees and tribal contacts at Sycuan, Barona and Jamul.

Tactics

The outreach tactics used to inform and engage target communities may include flyers, posters, word-of-mouth, posted information on the IRC website, the ABA website and websites of community-based organizations, social media, media releases, email distribution, newsletters, local newspapers (both print and digital versions), radio and Public Service Announcements (PSAs). See examples on pages 12 through 19.

Community Relations & Coalition Building

ABASD will continue to leverage long-standing relationships with community leaders at the local level to provide timely and pertinent information regarding the redistricting process to raise awareness, educate, and increase public participation. Coordinated distribution of information via the email lists of our respective CBO partners will play a critical role in this area. ABASD will also utilize the existing County of San Diego distribution lists and ask staff to distribute the communications as well.

Targeted Communications, Social Media & Advertising

ABASD will help IRC reach San Diego residents and communities no matter where they are. Beyond simply delivering traditional, “legacy” media programs (print and broadcast), ABASD’s team is partnered with leading providers of audience-based IP-addressable advertising solutions that span four (4) screens: desktop, mobile, tablet & TV – ensuring our digital outreach and engagement campaign is employing the very best tactics available.

In conjunction with IRC direction, the ABASD team will craft appropriate digital content for outreach distribution across relevant social media platforms for each district and among outreach partners including Facebook, Twitter, Instagram and LinkedIn. An emphasis on partnering with CBO’s for tagging and organic resharing will be utilized as part of the overall strategy.

Social Media

In conjunction with IRC direction, the ABASD team will craft appropriate digital content for outreach distribution across relevant social media platforms for each district and outreach partners. An emphasis on partnering with CBO’s for tagging and organic resharing will be utilized as part of the strategy. When appropriate, paid ads will be distributed digitally to target populations.

Public Education

Website

ABASD team secured a vanity website address www.DrawYourCommunity.com and will continue to update the IRC website to provide relevant redistricting information for dissemination to all partners, and for linking to all digital outreach efforts.

Earned Media

ABASD will communicate all opportunities for public engagement in the redistricting process to local TV, radio and print media and encourage media attendance at all public hearings. Media broadcast of the redistricting process increases the likelihood of broader public participation. ABASD will continue to develop Public Services Announcements as needed.

Public Hearings & Other Public Meetings of the IRC

As outlined herein, ABASD will orchestrate and assist with the execution of the agreed-to schedule of the two Draft Map Public Hearings. ABASD will assist with the development of methods to organize and coordinate improved public participation in the Draft Map Public Hearings and other IRC Regular and Special meetings and will coordinate with IRC staff as needed.

Venue Selection

Two Draft Map Public Hearings

Rationale and considerations for venue selection:

- Reasonably accessible to retired/older individuals
- Accessible to the working age population
- Adequate meeting room capacity to accommodate anticipated public turnout
- Reasonable transit and walkability scores, are relatively close to mass transit, major highways, freeways or expressways, and which are accessible to residents with mobility issues
- Adequate technical capability for virtual attendance in order to enable attendance by those who cannot attend in person, hard-to-reach populations and more distant, less-populated communities
- Adequate technical capability for computerized mapping activities

Additional consideration was given to areas that:

- are reasonably convenient to underrepresented communities and non-English speaking communities
- have a greater number of CBOs and planning groups
- are reasonably located to serve hard-to-reach and less-populated communities

Proposed Meeting Location and Start Time

Per current contract, ABASD will coordinate the following meetings:

- November 1st 1st Draft Map Public Hearing
- December 2nd 2nd Draft Map Public Hearing

At this time, and pending Commission input in light of newly enacted legislation, ABASD is recommending that both Draft Map Public Hearings be held at the County Operations Center (COC) located at 5520 Overland, San Diego, CA 92123, if available . The COC reasonably satisfies the venue-selection considerations set forth above and has in place, a variety of security measures.

Start Time

At this time, ABASD is recommending an earlier start time for the accessibility/ convenience of attendance to members of the public and account for increased public comments, increased complexity of meeting content and other factors.

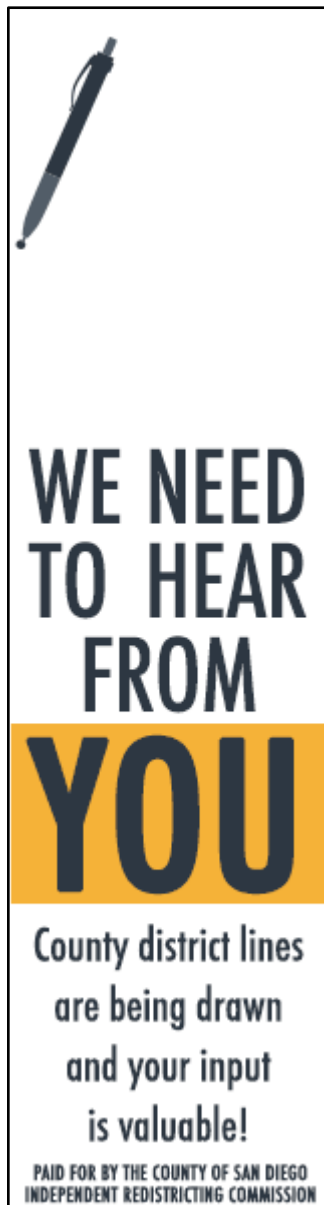


