COUNTY OF SAN DIEGO REDISTRICTING 2021

The County of San Diego Independent Redistricting Commission (IRC) is tasked with redrawing the boundaries for the County's five Supervisorial districts. The IRC acts independently from the influence of the Board of Supervisors and has a deadline of December 15, 2021 to adopt a final redistricting plan.

Redistricting takes place every 10 years after the federal census. The County's Supervisorial district boundaries will change so the five County Supervisors elected to represent those districts each serve about 650,000 residents and reflect the County's diverse population.

The IRC is now in the period of drawing draft maps. Each draft map will be published for public comment on the IRC website. There will also be public hearings during this map drawing phase to hear from the public about the proposed new district boundaries.

County residents are invited to provide input and participate in determining revisions to the Supervisorial district boundaries by joining the IRC online or in-person at the following meetings. **Virtual participation will be available for all meetings.** To participate by Zoom, visit www.drawyourcommunity.com for Zoom meeting information. 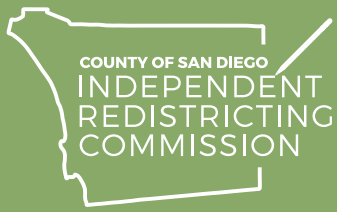

FEELING INSPIRED?

- ▶ Draw your community of interest using the Community Builder Tool at **www.drawyourcommunity.com**
(Provide as much detail as you can about your community and the characteristics or issues that bind you together and why you should be united in a single district)
- ▶ Draw your map using the District Scenario Modeler at **www.drawyourcommunity.com**
- ▶ Download a map, draw lines directly on the map and email to **redistricting@sdcounty.ca.gov**

WHAT TYPE OF FEEDBACK IS NEEDED?

EXAMPLES INCLUDE:

▶ **Do the current district boundaries still make sense?**

Look at the map of the current supervisorial districts and consider if they still make sense. To use the "Find my District" tool, visit www.sandiegocounty.gov/general/bos.html

▶ **What is your Community of Interest (COI)?**

A COI is a contiguous population that shares common social or economic interests that should be included within a single district for purposes of effective and fair representation. Think about populations who share common issues, physical features, entities like military bases, malls, schools, hospitals, parks, religious places, or social services OR street festivals, parades, or other events.

▶ **Where should the lines be drawn?**

Consider natural boundaries such as freeways, roads, rivers, natural features or anything else which may create a barrier or obvious line.
