III. APPROVAL OF MINUTES FOR THE MEETING OF NOVEMBER 28, 2022 (VOTE)

ON MOTION of Member Summers, seconded by Member Kellogg, the Advisory Board approved the Minutes of November 28, 2022 with the spelling correction of "evacuation corridors" instead of "evaluation corridors" on page 3, Item V, B. Motion carried.

IV. MANAGEMENT TEAM REPORT

- A. Fire Chief's Update (Deputy Chief Jason Malneritch)
 - 1. Continue to move towards two dual driver operators on all outlying fire stations which allows both an engine response in tandem with a water tender.
 - 2. Two additional ALS units: Medic 81 up and running at Ramona Fire Station and Medic 31 operating out of South County Potrero Station, serving Tecate port of entry and outlying areas. Both are staffed 24/7 with dual paramedics.
 - 3. Recently wrapped up the 11th County Fire Truck Academy which provides advanced training and rescue techniques to those who work on our urban search and rescues as well as the ladder truck in Otay.
 - 4. Medical Priority Dispatch (MPD) working in collaboration with Medical Director Dr. Dave Duncan to review policy and get approved, which will help prioritize emergency response to send Code 3 resources to where they are needed and send Code 2 BLS resources to where they are better utilized. To ensure calls are being processed appropriately and getting the right medical direction and following up to ensure we are giving appropriate outcomes.
 - 5. Water Rescue Teams being staffed due to the weather/storm. There have been a number of water rescues.
 - 6. Working actively in collaboration with County Probation on a concept of a County Fuels Crew/Fire Crew. The primary focus is to provide positive training and reinforcement to enter a pathway of employment once they have completed their program.

Fire Mitigation Fee—Continuation of discussion on the pending Board of Supervisors Action to Adopt a Nexus Study and updated Ordinance for the County's regional Fire Mitigation Fee Program and the upcoming Board of Directors Action to adopt a resolution setting the updated Fire Mitigation Fee rates for the San Diego County Fire Protection District

In 1985, the Board of Supervisors established the Fire Mitigation Fee (FMF) Ordinance for fire protection districts, under the law, to impose fees and offset the impacts of development on public facilities or services. For San Diego County, Planning and Development Services collects fees when building permits are issued and disperses funding quarterly. San Diego County Fire serves as the program administrator to meet state legislative requirements, including annual reporting of information.

Since the FMF program was initially approved, there have been changes to State law, County strategic initiatives, industry standards and community needs that impact provision of fire protection and emergency medical services throughout the unincorporated areas of the region. Over the past year, staff have coordinated with a consultant, participating agencies and the public to generate a study to determine the appropriate level of fees for the program.

In accordance with AB 602 requirements, the Board of Supervisors will adopt the findings of the comprehensive nexus study documenting the connection between development and fire and emergency medical and replace the existing County FMF Ordinance with an updated version. The updated regional ordinance will be adopted by the Board of Directors of each of the participating local fire agencies, including the San Diego County Fire Protection District.

Recommendation: Receive a report on County staff efforts to update the Fire Mitigation Fee to meet the criteria established in AB 602 for comprehensive nexus studies. Support the proposed FMF increase for the San Diego County Fire Protection District.
