## **POOL ALARM USE AGREEMENT – PG. 1 OF 2**

This Pool Alarm Use Agreement ("Agreement") is entered into by and between the San Diego County Fire ("County") and owner ("Owner") of a residence located at the address provided below ("Property"), and when applicable, a non-owner occupant of the Property ("Occupant"). This Agreement is effective as of the date of last signature.

County and Owner, and when applicable, Occupant, desire to enter into this Agreement so that County may provide a pool alarm for use at the Property. The pool alarm is an alarm with remote receiver designed to sound an alarm should a child or pet fall into a pool.

### **1. COUNTY'S COVENANTS AND OBLIGATIONS**

- 1.1. County agrees to provide a pool alarm to Owner for use at the Property free of charge.
- 1.2. County, its employees, and agents (collectively, "County") assume no responsibility for the pool alarm, including but not limited to, the installation, use, or misuse of the pool alarm.

### **2. OWNER'S COVENANTS AND OBLIGATIONS**

- 2.1. Owner agrees to indemnify, hold harmless, and defend the County from any claims, demands, liability, judgments, awards, fines, mechanics' liens or other liens, labor disputes, losses, damages, expenses, charges or costs of any kind or character, including attorneys' fees and court costs, related to the pool alarm made by the Owner, Occupant, any resident of the Property, or any third party, including but not limited to, the installation, use or misuse of the pool alarm.
- 2.2. Owner agrees not to use or authorize use of the pool alarm other than for its intended purpose.

### **3. OCCUPANT'S COVENANTS AND OBLIGATIONS**

- 3.1. Occupant has voluntarily requested that the County deliver the pool alarm to the Property for installation in an above or below ground pool or spa at the Property and authorizes such deposit.
- 3.2. Occupant agrees to indemnify, hold harmless, and defend the County from any claims, demands, liability, judgments, awards, fines, mechanics' liens or other liens, labor disputes, losses, damages, expenses, charges or costs of any kind or character, including attorneys' fees and court costs, related to the pool alarm made by the Owner, Occupant, any resident of the Property, or any third party, including but not limited to, the installation, use or misuse of the pool alarm.
- 3.3. Occupant agrees not to use or authorize use of the pool alarm other than for its intended purpose.

### **4. GENERAL PROVISIONS**

- 4.1. This Agreement constitutes the complete agreement between the parties. All prior or contemporaneous agreements, understandings, representations, warranties and statements, oral or written are superseded.
- 4.2. If the County takes legal action to enforce this Agreement, the County shall be entitled to recover all reasonable costs and expenses, including attorneys' fees.
- 4.3. Each and every provision of law and clause required by law to be inserted in this Agreement shall be read and enforced as though it were included herein. If for any reason any such provision is not inserted, or is not correctly stated, then upon application by any party, the Agreement shall be amended to make the insertion or correction.
- 4.4. This Agreement shall be governed, interpreted, construed and enforced in accordance with the laws of the State of California. Venue and jurisdiction for any disputes concerning this Agreement shall be in the state courts for the County of San Diego, California or the federal court for the Southern District of California.
- 4.5. All terms of this Agreement shall be binding upon, inure to the benefit of, and be enforceable by the parties hereto and their respective heirs, legal representatives, successors, and assigns.

## **Pool Patrol Pool Alarm With Remote Receiver** Poolweb #PA-30

### **Description**

The Pool Patrol Model PA-30 is an alarm with remote receiver designed to sound an alarm should a child or pet fall into a pool. This model sounds the alarm at the site of the alarm and where the remote receiver is placed (up to 200 feet).

The Pool Patrol has wave detecting technology designed to protect loved ones and keep your pool safe and enjoyable. The Pool Patrol floats on the pool surface and will activate when children or pets (15 lbs. or more) fall into the pool, creating a wave. The PA-30 will sound a clear warning alarm at the pool (PA-30 location) and sound an alarm remotely where the remote receiver(s) are placed. The sensing ring is adjustable so that it can be controlled to activate only when an object the size of a child or pet falls into your pool. The Pool Patrol Pool Alarm comes with easy-to-use tie-down strings and hooks. This enables the Pool Patrol to be secured to the side of your pool.

The remote wireless receiver has an on/off switch with an "on" indicator light and is powered by a 120 volt A.C. wall transformer. The alarm in the pool is battery powered and uses one 9 volt alkaline battery.

The Pool Patrol Alarms are not meant to replace any other safety considerations like adult supervision, lifeguards, pool covers, fences, etc. They are designed to provide an extra layer of protection should something happen when you are not nearby.

The Pool Patrol is designed to work in any shape pool. This product is ideal for both inground and aboveground pools, but it also protects commercial pools and spas. Pool Patrol products are tested and approved and meet the requirements of ASTM Safety Specification F2208 for home safety products.

Please ensure you spend sufficient time in becoming familiar with the operation of your Pool Patrol Alarms and to properly test the unit ensuring that it adequately covers all areas of the pool for the person(s) or pet(s) you wish to protect.
