# COMMUNITY DEVELOPMENT BLOCK GRANT PROGRAM TO ASSIST LOW- AND MODERATE-INCOME PERSONS AFFECTED BY CORONAVIRUS

The County of San Diego, Housing and Community Development Services, is now accepting grant applications for the Community Development Block Grant – Coronavirus (CDBG-CV) Program. The County has approximately \$4 million available for funding. The main objectives of the CDBG-CV funds are to prevent, prepare for, and respond to Coronavirus, particularly to benefit persons of low- and moderate-income. Depending on the project, federal money may be available for your community. Non-profit entities working in the unincorporated area of the county may propose projects for CDBG funding that benefit low- and moderate-income persons and align with the <a href="County's Consolidated Plan">County's Consolidated Plan</a>. Additionally, the project must demonstrate a clear connection to the Coronavirus pandemic.

## Who may apply?

Any non-profit organization that serves populations within the Urban County.

## What kind of projects are eligible?

The following are a list of eligible CDBG-CV program activities to meet the stated objectives: (1) public service activities, (2) housing-related activities, (3) public improvements and facilities, (4) activities to acquire real property, (5) economic development activities, and (6) general administrative and planning activities. #### Who should the projects benefit?

All activities must benefit residents within the jurisdiction of the County of San Diego Urban County. This includes unincorporated San Diego, as well as the cities of Coronado, Del Mar, Imperial Beach, Lemon Grove, Poway, and Solana Beach. The beneficiaries of the project/program are at least 51% residents whose incomes are at or below 80% of AMI (see chart below). Additionally, the project must serve individuals and families who have been affected by the Coronavirus pandemic.
