Monthly Unincorporated Regional Homeless Services - Definitions and Notes

Program Description:

The “Unincorporated Regional Homeless Services” dashboard offers a comprehensive view of homelessness trends and program outcomes in the County’s unincorporated areas. It tracks data on the Regional Homelessness Assistance Program (RHAP), Safe Parking Programs, the Office of Homeless Solutions’ regional services, and encampment abatement efforts led by the Department of Public Works.

Definitions:

- Homeless individuals in Unincorporated (beginning of month): Number of individuals experiencing homelessness in the unincorporated area of the County at the beginning of the reporting month.
- Inflow: Number of new individuals experiencing homelessness in the unincorporated area of the County during the reporting month; this may also include individuals who exited the area but returned to homelessness in the area during the reporting month.
- Outflow: Number of individuals who exit the unincorporated area of the County during the reporting month. Exits may include those who obtain housing, enter into shelter, hospital or institution or have an unknown exit destination.
- Homeless individuals in Unincorporated (End of Month)s: Number of individuals who continue to experience homelessness in the unincorporated area of the County during the reporting month.
- Encounters: Number of outreach encounters with individuals experiencing homelessness in the unincorporated area documented by Office of Homeless Solutions staff.
- OHS Regional Services: Number of individuals experiencing homelessness in the unincorporated area of the County who have engaged with Office of Homeless Solutions during the reporting month.
- Regional Homeless Assistance Program: Number of individuals experiencing homelessness in the unincorporated area of the County who were served through the Regional Homelessness Assistance Program (RHAP) during the reporting month.
- Safe Parking: Number of individuals experiencing homelessness in the unincorporated area of the County who participated in the Safe Parking programs.
- Encampment Clean Ups: Number of encampment clean-ups completed during the reporting period.
- Waste Cleaned: Cubic yards of waste collected during encampment clean-ups during the reporting period.
- Exits to Housing: Number of individuals experiencing homelessness in the unincorporated area of the County who transitioned from unsheltered homelessness to permanent or temporary housing, a hospital or institution or entered into shelter during the reporting period. Reflects the combined data for RHAP, Safe Parking and OHS Regional Services programs.
- Demographics (Age, Race & Gender): It is the combined demographics for individuals for the Safe Parking and OHS Regional Services and for head of household for the Regional Homelessness Assistance Program.

Notes:

Due to rounding, some percentage totals may equal 99% or 101%.
