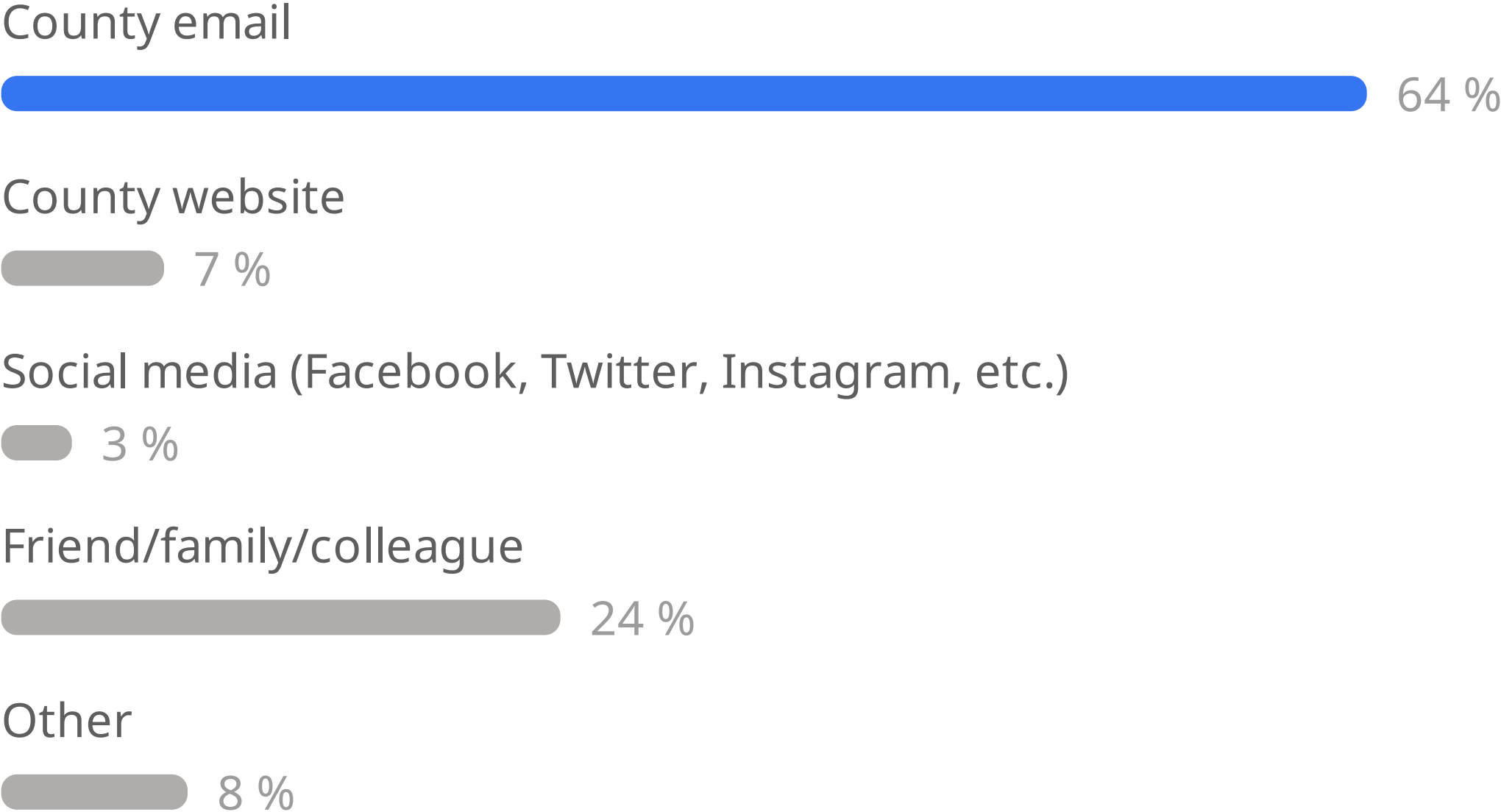

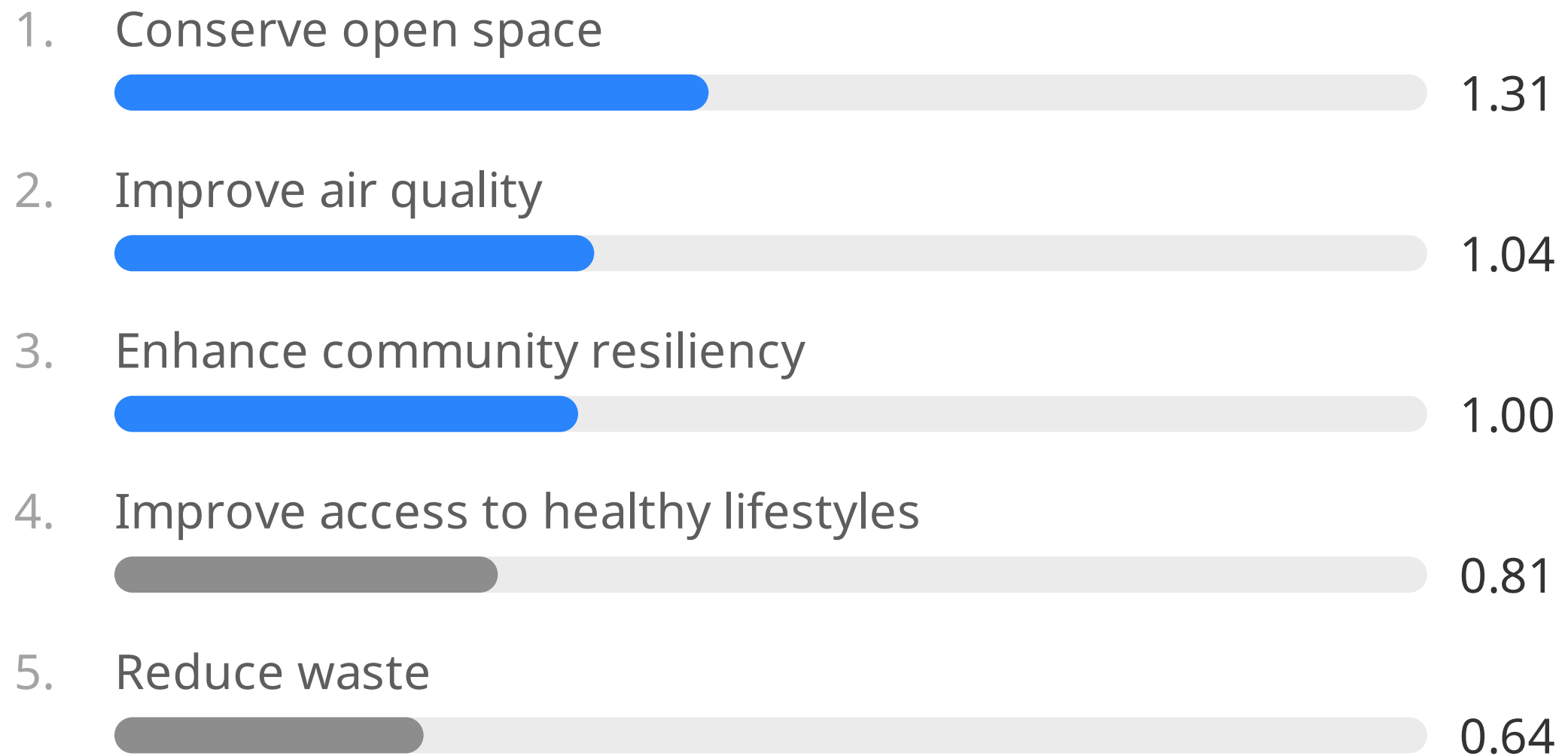

Which of the following outcomes are the most important to you?

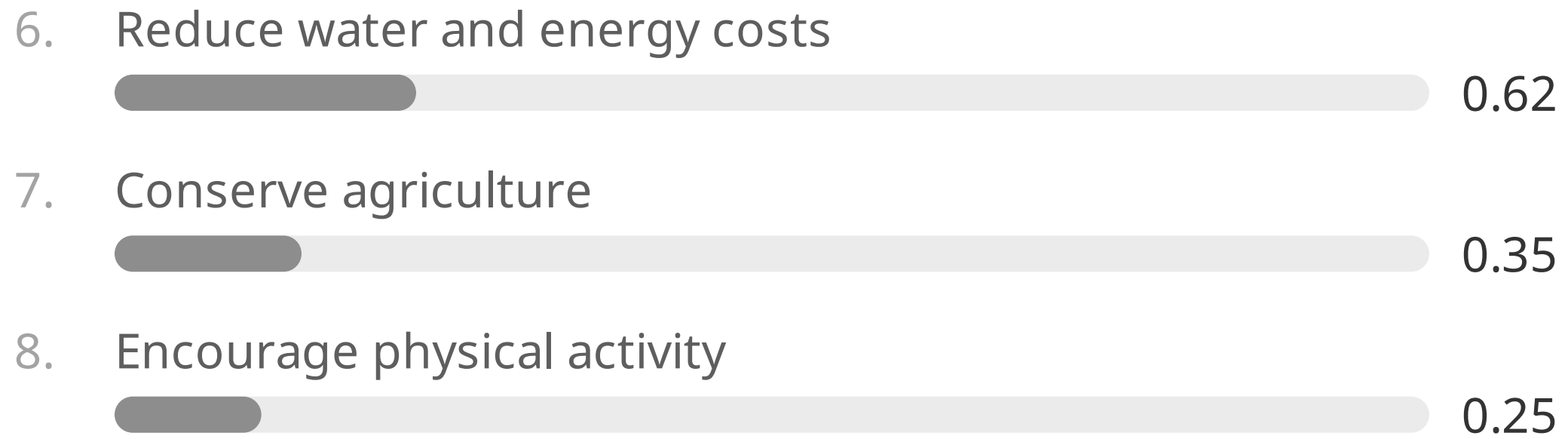

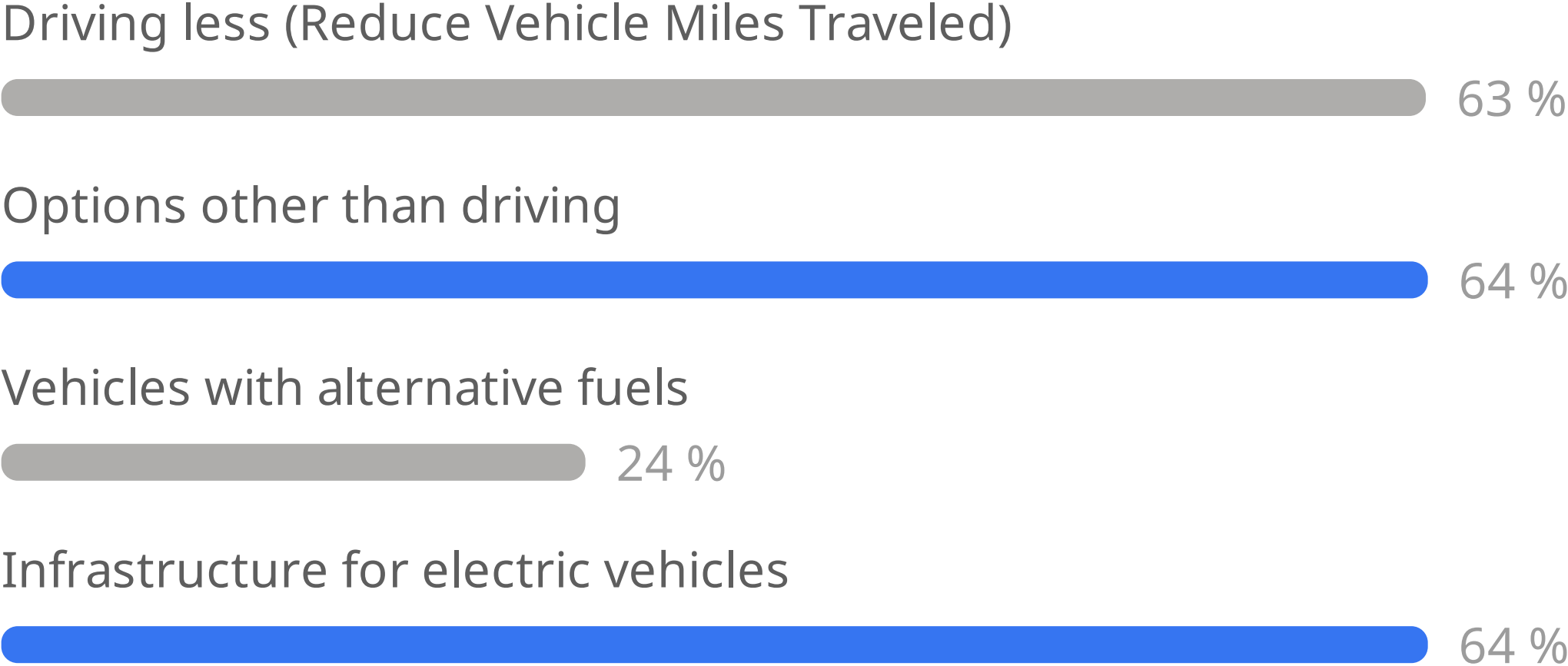

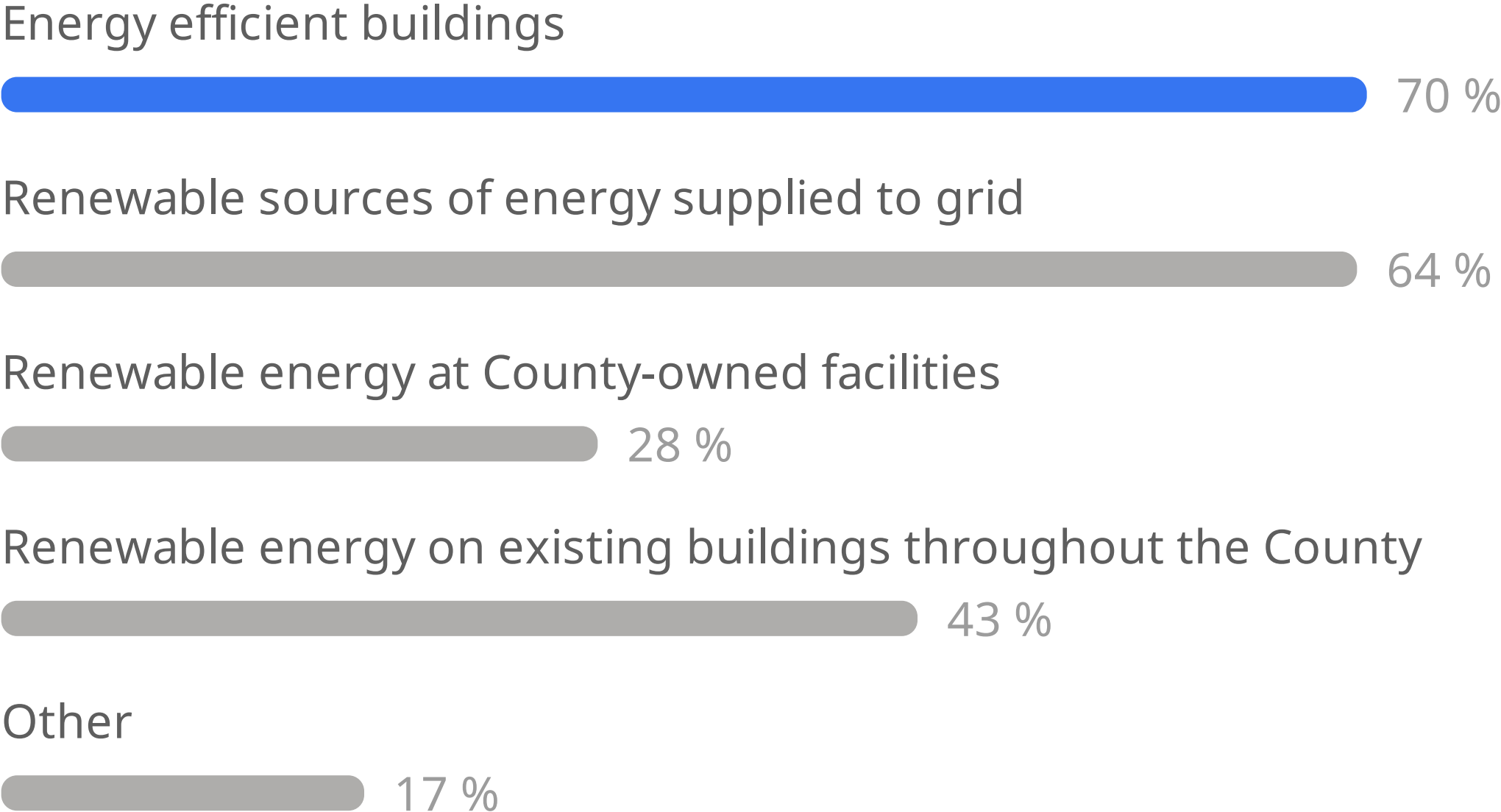
