Purpose of the Scoping Meeting

- Provide information early in the CEQA process
- Get your input on Climate Action Planning Strategies and Measures
- Solicit your input on the scope of the environmental analysis, including environmental issues, alternatives, and mitigation measures we should study in the Supplemental EIR



Why a Climate Action Plan?

- The County's 2011 General Plan recognized the relationship between local GHG emissions and climate change
- The General Plan EIR contained mitigation consistent with AB 32- Global Warming Solutions Act
- The CAP mitigates emissions that will occur from development in the unincorporated areas of the county and from operating County-owned facilities
- County prepared 2012 CAP and 2018 CAP in prior iterations

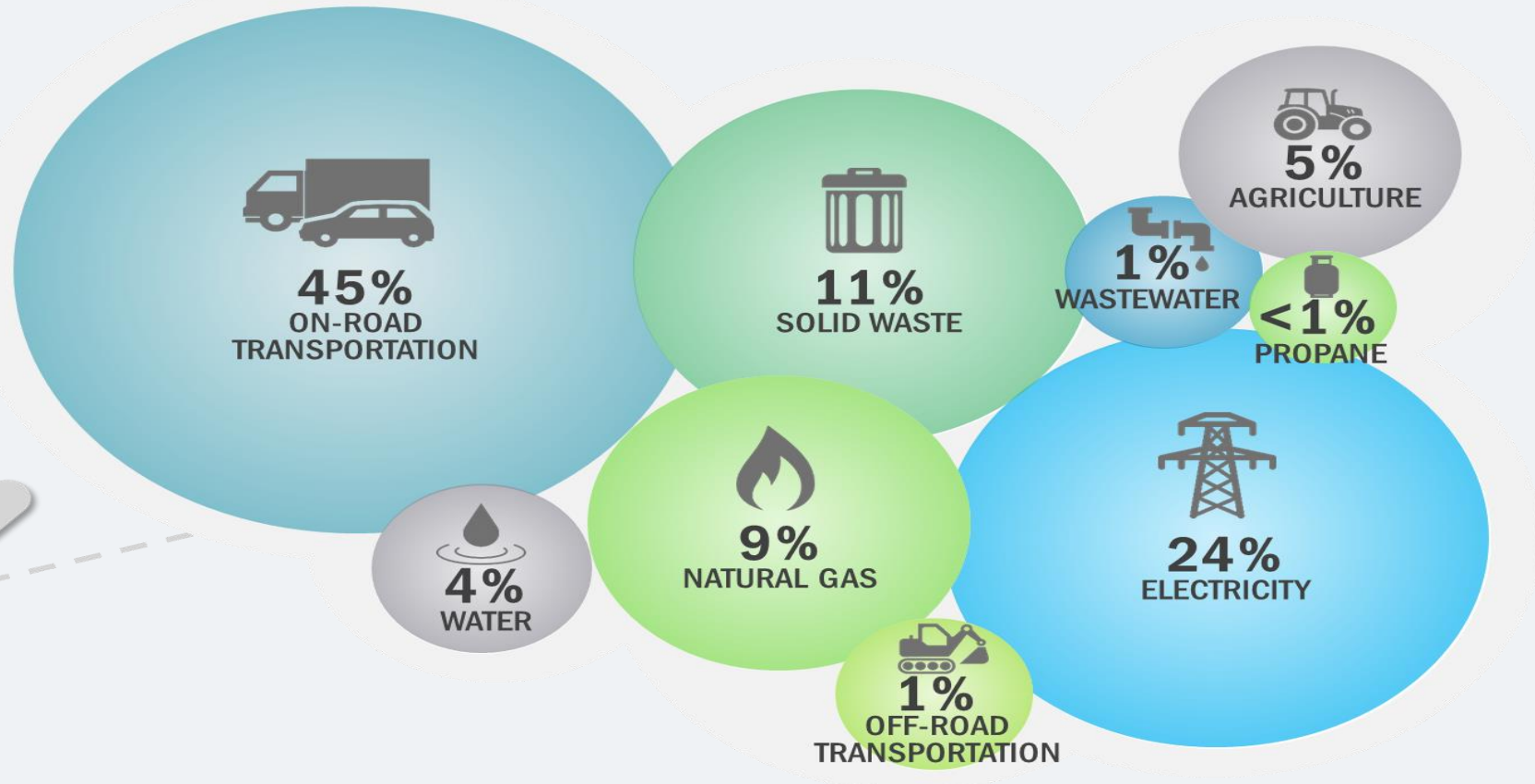
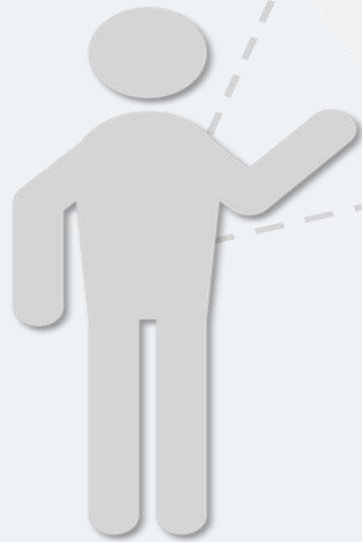


What is a Climate Action Plan?

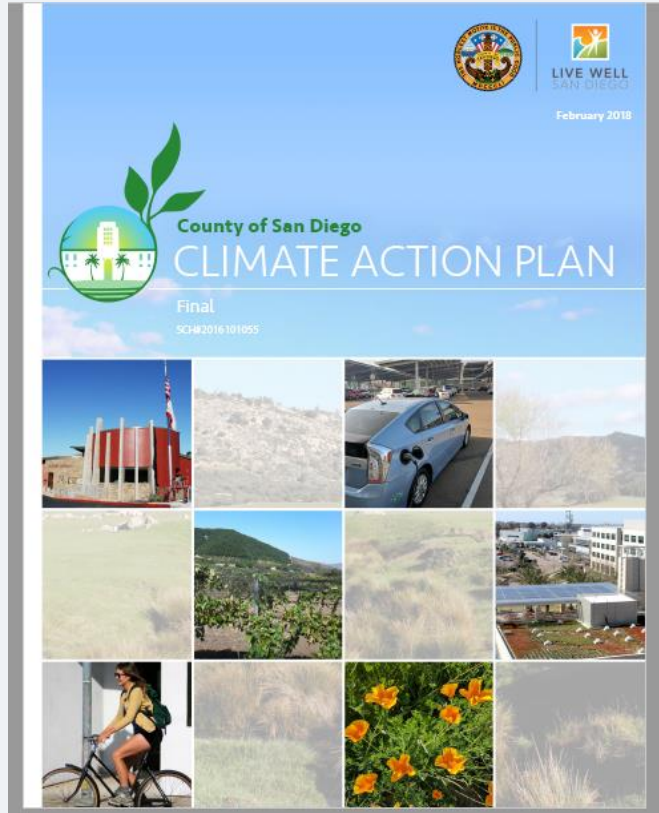
- A greenhouse gas reduction plan
 - Series of policies, programs, or initiatives that the County can implement to reduce greenhouse gas emissions
- Elements of a CAP
 - Greenhouse gas emissions inventory of unincorporated area and County facilities
 - Projections of emissions scenarios through 2050
 - Greenhouse gas emissions targets through 2050
 - CAP measures (policies) that will reduce greenhouse gas emissions through 2050

2018 Climate Action Plan Measures



- Adopted 2018
- Contains 26 measures in the following 5 sectors:
 - Built Environment and Transportation
 - Energy
 - Water and Wastewater
 - Solid Waste
 - Conservation/Agriculture

Current Board Direction

- Legally enforceable
- No purchase of carbon offsets to meet emission reduction targets
- Updated data and modeling
- Emphasizes environmental justice and equity
- Shaped by community input
- Exceeds Senate Bill 32 greenhouse gas emissions reductions
- Meets net zero carbon emissions by 2035-2045
- Receive input and direction from the Environmental Advisory Committee

Prepare Supplemental EIR

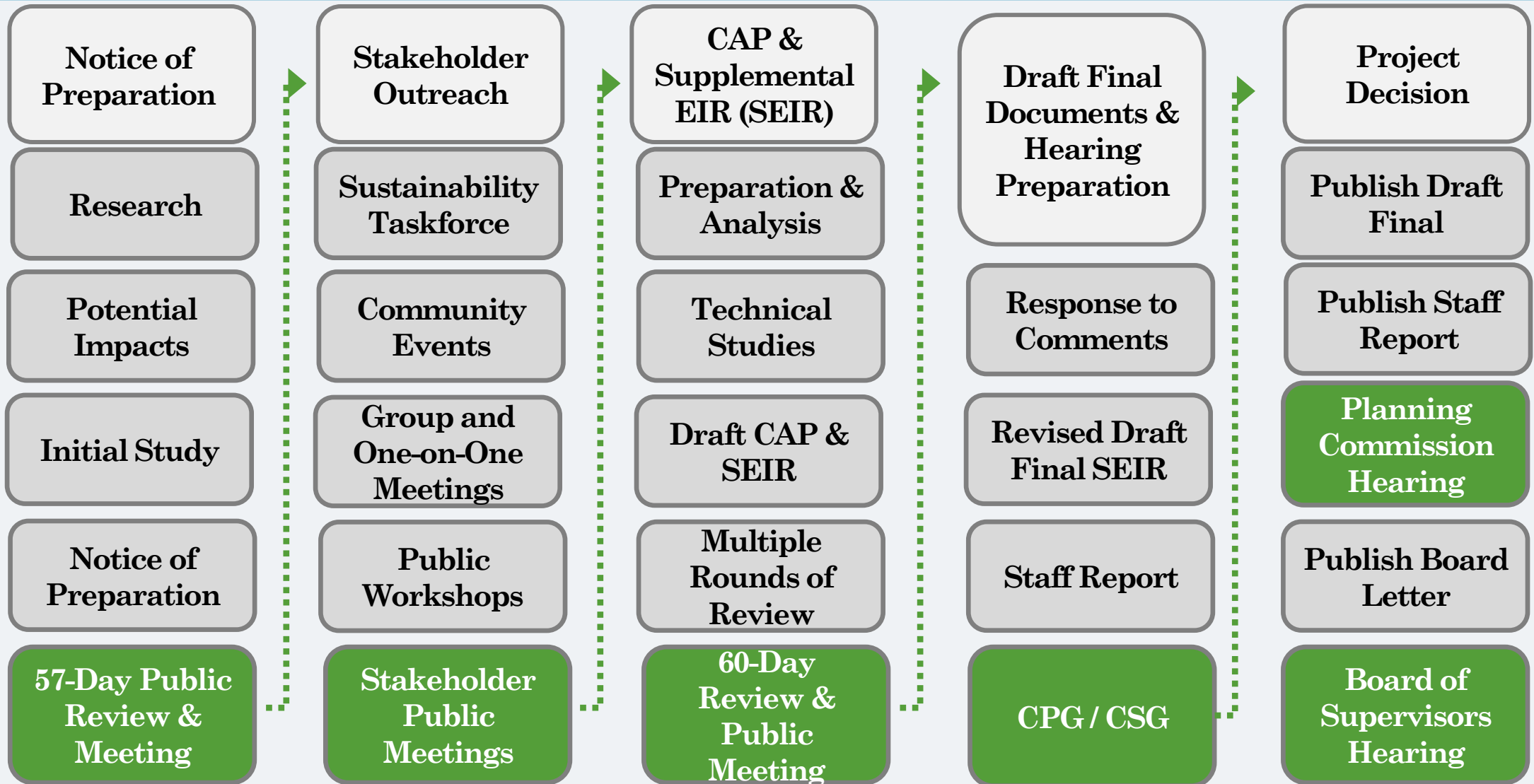
The Court directed:

- Revise or delete mitigation measure allowing carbon offsets
- Revise the Cumulative Impacts Analysis
- Evaluate “Smart Growth” Alternative(s) to reduce vehicle miles traveled
- Evaluate consistency with SANDAG Regional Plan

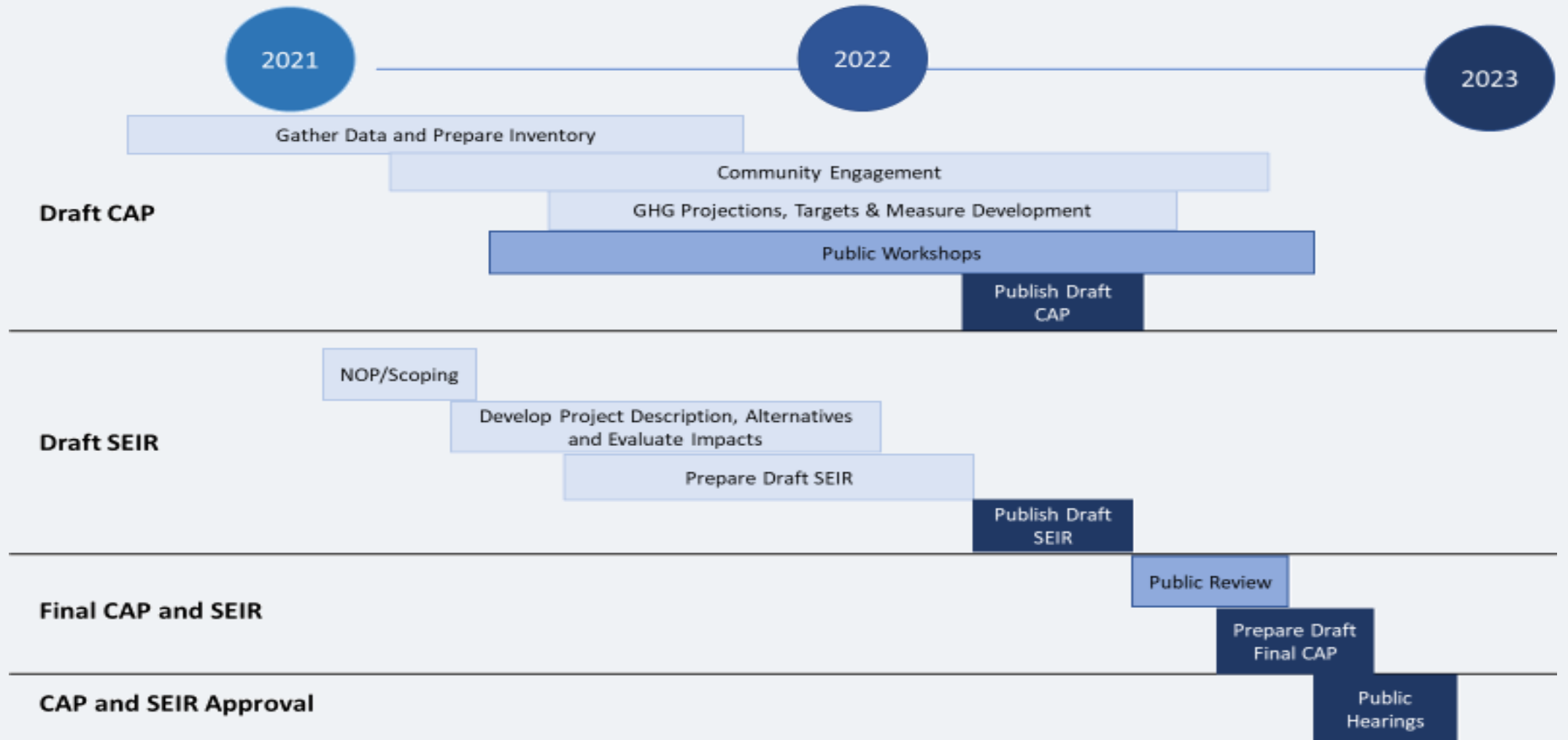




